

Policy & Procedure of Vidya Yoga & Fitness Child Watch

Illness

Children with fever and any symptoms of illness will not be permitted in Child Watch.

Illness includes any of the following:

- 1) A fever or has had a fever within the last 24 hours
- 2) Mucus that is green, white, or brown
- 3) A persistent cough
- 4) Unexplained rash or blisters
- 5) Diarrhea
- 6) Vomiting
- 7) Pink Eye
- 8) Lice

Personal Belongings

Neither VY&F or Child Watch personnel is responsible for loss or damage to any personal items. Please label all personal items. Medications will not be administered by Child Watch staff.

Food & Drinks

Food and drinks of any variety are not allowed in the Child Watch area. Please feed your child before bringing them to Child Watch.

Inconsolable Child Policy

If a child remains inconsolable after 15 minutes, the parent will be notified by staff to address the child's needs.

A parent or legal guardian must remain at VY&F the entire time during a Child Watch reservation. This is mandated by the State of Tennessee in accordance with our childcare exemption status.

VIDYA Yoga & Fitness Child Watch Liability Waiver

WAIVER AND RELEASE OF LIABILITY Short-Term Child Supervision

I, the undersigned, understand and acknowledge that VY&F Fitness is not a licensed childcare facility, and that the temporary supervision of my child/children is a service VY&F may provide only while I am present at the training site ("Location") for the sole purpose of participating in VY&F classes ("Classes"). I hereby grant permission for my child to be temporarily supervised by VY&F (including its officers, employees, representatives, agents, contractors, volunteers, successors and assigns - collectively, VY&F Staff) while I participate in classes. In the event that I am injured during classes and that injury makes me unavailable or unable to attend to my child, I hereby give VY&F my express written permission to contact the Emergency Contact listed herein and acknowledge that they may release my child into their custody if required. I understand that VY&F reserves the right to decline temporary supervision of any child for any reason, at VY&F's sole discretion. I hereby hold harmless, waive and release VY&F from any and all liability in connection with any personal injury or property damage or loss that may occur while my child is supervised by VY&F at any Location. I agree not to sue VY&F and release all rights to make a claim against or sue VY&F in connection with the supervision of my child. I further agree to defend and indemnify VY&F for any and all claims arising in connection with VY&F supervision of my child. I understand that if my child should become inconsolable or present any behavioral issues negatively impacting other children or VY&F staff during the classes, it is my responsibility to leave classes and attend my child. I understand it is my sole responsibility to inform VY&F with any and all information about any allergies, sensitives, behavioral issues my child may have that may impact my child or any other child's health or well-being.

In consideration for being allowed to participate and/or enroll my child to participate in the activities relating VIDYA Yoga & Fitness (VY&F), I hereby expressly reassume all risks and hazards, both known and unknown, incidental to my child's participation in Child Watch and assume full responsibility for all risks of bodily harm and property damage resulting from or in connection with my child's participation in Child Watch, including without limitation. I hereby voluntarily release, waive and forever discharge and agree to indemnify and hold harmless, VIDYA Yoga & Fitness, its officers, employees, agents, representatives and related persons (collectively the "Releasees") and from any and all liabilities, claims, damages, injuries and losses, including attorney's fees and courts costs, resulting from, arising out of or connected in any way with my child's participation in the Child Watch and related activities; and further agree to indemnify, defend and hold the Releasees harmless from and against any and all liabilities, claims, damages, injuries and losses, including attorney's fees and courts costs, for personal injury or property damage to any person or entity resulting from or related to my child's participation in the VY&F Child Watch.

I acknowledge that I have read and understand the liability waiver and the policy and procedures pertaining to Vidya Yoga & Fitness Child Watch.
